PUBLIC COMMENT ON NON-AGENDIZED ITEMS:

A representative from California Special Districts Association (CSDA) informed the board about CSDA's call to action to oppose SB 13, which restricts districts from being able to charge impact fees for accessory dwelling units that are 750 square feet or less.

A. Presentation of the District Transparency Certificate of Excellence by the Special District Leadership Foundation.

Dane Wadle, representative from California Special Districts Association and Special District Leadership Foundation, commended the district for their transparency efforts and presented the board with the District Transparency Certificate of Excellence.

B. Tour of the Fire Division training simulation table.

Chief McNeal provided a tour of the newly constructed fire training simulation room and simulation table in the Vantage Pointe office facility. Chief McNeal demonstrated how the simulation table and room could be used to simulate fire events with 3-dimensional modeling, providing real-time emergency operations center and command training. Chief McNeal stated that the training facility could be used to accommodate a small emergency operations center in the event of a real incident that threatened the District.
